17 **For An Act To Be Entitled**

18 AN ACT TO CREATE A SYSTEM FOR FULLY TRANSFERABLE  
19 CREDIT HOURS FROM DEGREES IN ASSOCIATE OF ARTS,  
20 ASSOCIATE OF SCIENCE, AND ASSOCIATE OF ARTS IN  
21 TEACHING AMONG PUBLIC INSTITUTIONS OF HIGHER  
22 EDUCATION; AND FOR OTHER PURPOSES.

24 **Subtitle**

25 THE ROGER PHILLIPS TRANSFER POLICY ACT.

26  
27  
28 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

29  
30 SECTION 1. Arkansas Code Title 6, Chapter 61, Subchapter 2, is amended  
31 to add an additional section to read as follows:

32 6-61-231. Statewide Transfer Agreement.

33 (a) As used in this section:

34 (1) "Designated transfer degree" means one of the following  
35 associate degrees that is eligible for the full transfer under this section



1 of credits earned and hours completed:

2 (A) Associate of arts;

3 (B) Associate of science; or

4 (C) Associate of arts in teaching;

5 (2) "Lower division credits" means freshman and sophomore level  
6 course credits;

7 (3) "Public institution of higher education" means an Arkansas  
8 state-supported two-year or four-year college or university; and

9 (4) "Transfer student" means a student transferring from a  
10 completed designated transfer degree program to a baccalaureate program at a  
11 four-year public institution of higher education.

12 (b) The purpose of this section is to eliminate obstacles to transfers  
13 of credits among public institutions of higher education in Arkansas by  
14 providing a seamless transfer of academic credits from a completed designated  
15 transfer degree program to a baccalaureate degree program without the loss of  
16 earned credits and without the receiving public institution of higher  
17 education requiring additional lower division credits.

18 (c) By January 1, 2010, the Arkansas Higher Education Coordinating  
19 Board shall develop a statewide transfer agreement that:

20 (1) Designates the following as transfer degrees at public  
21 institutions of higher education in Arkansas:

22 (A) Associate of arts;

23 (B) Associate of science; and

24 (C) Associate of arts in teaching;

25 (2) Requires a four-year public institution of higher education  
26 to accept all hours completed and credits earned for a designated transfer  
27 degree upon a student's transfer to a baccalaureate degree program at the  
28 four-year public institution of higher education;

29 (3) Contains the transfer curriculum for each designated  
30 transfer degree that is approved by the board under subsection (d) of this  
31 section;

32 (4)(A) Requires a four-year public institution of higher  
33 education to admit a transfer student to junior status in a baccalaureate  
34 degree program at the four-year public institution of higher education.

35 (B)(i) A four-year public institution of higher education  
36 receiving a transfer student shall not require additional lower division

1 credits for the transfer student if the additional course is considered a  
2 general education lower division course.

3 (ii) The receiving four-year public institution of  
4 higher education may only require the additional lower division course if the  
5 additional lower division course is:

6 (a) A prerequisite for courses in the transfer  
7 student's baccalaureate degree program;

8 (b) A discipline-specific course that is  
9 required by the transfer student's baccalaureate degree program and the  
10 student has not completed a course at the two-year public institution of  
11 higher education that is comparable to the discipline-specific course at the  
12 four-year public institution of higher education in the Arkansas Course  
13 Transfer System; or

14 (c) A requirement of an independent licensing  
15 or accrediting body.

16 (C) This subsection (c) does not remove the requirement  
17 that a transfer student must meet total baccalaureate degree program credit  
18 hour and course requirements in order to be eligible for a baccalaureate  
19 degree

20 (D) The receiving four-year public institution of higher  
21 education shall determine whether to accept a grade of "D" for academic  
22 course credit for a student transferring from a two-year public institution  
23 of higher education; and

24 (5)(A)(i) Requires a four-year public institution of higher  
25 education to develop transfer guidelines for each two-year public institution  
26 of higher education that has a campus within fifty (50) miles of the four-  
27 year public institution of higher education.

28 (ii) If a two-year public institution of higher  
29 education does not have a campus that is within fifty (50) miles of a four-  
30 year public institution of higher education, the four-year public institution  
31 of higher education that is nearest to the two-year public institution of  
32 higher education shall develop the transfer guidelines under this subdivision  
33 (c)(5).

34 (B) The guidelines shall outline courses for each four-  
35 year public institution baccalaureate degree program which will prepare  
36 students for entry into that baccalaureate degree program without additional

1 general education credits.

2 (C) Transfer guidelines are only for the purpose of  
3 student advising and do not exempt a four-year public institution of higher  
4 education from the requirements of subdivision (c)(4) of this section.

5 (d) The board, with the assistance and cooperation of the public  
6 institutions of higher education, shall develop:

7 (1) A transfer curriculum for each designated transfer degree;

8 (2) Policies and procedures for reviewing and updating the  
9 statewide transfer agreement; and

10 (3)(A) Policies and procedures for the Department of Higher  
11 Education to collect data from public institutions of higher education to  
12 ensure that:

13 (i) All public institutions of higher education  
14 comply with this section; and

15 (ii) The statewide transfer agreement is fostering  
16 both a seamless transfer process and the academic success of transfer  
17 students at Arkansas public institutions of higher education.

18 (B) The department shall determine annually the data to be  
19 collected and shall establish by rule the procedures for a public institution  
20 of higher education to provide the data requested.
