EVIDENCE TABLES FOR CRITERION 2 Section 2A, 2B, 2C, and 2E

WHAT IS EVIDENCE

Evidence documents support the Assurance Argument. Examples of sources of evidence common to most Assurance Arguments include: mission statements, budget documents, assessment and curriculum reports, minutes from meetings of governing boards and other important committees, and materials related to special accreditation organizations or state agencies.

Much of the evidence in the file will be uploaded from the Catalog, Class Schedules, Faculty Rosters, Faculty, Staff, and Student handbooks.

HLC will include evidence from their file, such as team reports from Comprehensive Evaluations, analysis of Interim Reports, Institutional Updates, copies of actions and correspondence, and public comments.

THE ASSURANCE ARGUMENT

An important feature of the Assurance Argument is the criterion in its entirety.

Criterion 2. Integrity: Ethical and Responsible Conduct

In fulfilling its mission, the institution acts with integrity; its conduct is ethical and responsible.

As noted above in Institutional Mission, an institution's distinctive mission will inform how it demonstrates that it meets the following Core Components of Criterion 2.

Each subcomponent must be read in terms of the entire criterion.

2.A. Integrity

Actions taken by the institution's governing board, administration, faculty and staff demonstrate adherence to established policies and procedures.

2.B. Transparency

The institution presents itself accurately and completely to students and the public with respect to its educational programs and any claims it makes related to the educational experience.

2.C. Board Governance

In discharging its fiduciary duties, the institution's governing board is free from undue external influence and empowered to act in the best interests of the institution, including the students it serves.

2.D. Academic Freedom and Freedom of Expression

The institution supports academic freedom and freedom of expression in the pursuit of knowledge as integral to high-quality teaching, learning and research.

2.E. Knowledge Acquisition, Discovery and Application

The institution adheres to policies and procedures that ensure responsible acquisition, discovery and application of knowledge.

WRITING THE ASSURANCE ARGUMENT

As we write the Assurance Argument, we think about how to frame the wording. The way it is worded or supported now may be different once we publish the document. For example,

We may decide to consolidate all of the evidence and change the argument to reflect our evidence in a different way. We may identify evidence by consolidating all docs under “opportunities for civic engagement”.

*PCCUA provides **opportunities for civic engagement** in a diverse, multicultural society and globally connected world as appropriate within its mission, values, and vision. Through service projects, course projects, capstone experiences, student activities, and clinicals and practicums, students learn to navigate community and world experiences mirroring future pursuits.*

Please look at the evidence list for Criterion 2, Section 2A. We have listed the documents we feel can be used.

Evidence can take many forms, such as documents, flyers, posters, reports, pictures, screenshots, and more.

One thing is for certain: once we get the Assurance Argument together, the evidence file will be much smaller. Items listed as separate pieces of evidence will be tied to the HLC permissible documents such as the handbooks and schedules. Many items will come from the policy manual.
